## Communication

**A. President's Report-**Dr. Gray reported that the College has new articulation agreements. Dr. Gray also visited Allegheny College and discussed several opportunities for partnerships. Dr. Gray also met with County Executive, Brenton Davis along with UPMC Hamot, Allegheny Health Network, and LECOM to discuss county wide partnerships to provide training for the health care industries. Dr. Gray also notified the Board of upcoming PA Commission for Community Colleges (PACCC) trustee meetings that they may attend. Trustee Hersch asked how the articulation agreements work. Dr. Gray explained that the details vary per agreement, but the institutions accept all courses on a one-on-one basis but promise to take the credits.

**B. Academic Committee-**Committee Chair Secretary Wagner, MD announced that the first committee meeting with new members met yesterday. She highlighted that the committee is bringing forth the policy change for Academic Standing tonight that is pro student. She also informed the trustees that standing committee meetings had been set for the new year.

### **Presentation- Erie School District Dual Degree with EC3**

Dean Rebecca Walker explained that dual degree means that students are taking one set of courses that count towards two degrees simultaneously. This cohort runs annually. The first cohort has 6 students participating, but, moving forward, the goal is 20 students. She stated that EC3 is the only program where the college credits count towards their core high school credits as well as college credits towards a degree vs general education credits. The first dual degree cohort is with the Erie School District. There are plans to offer a dual degree program for county high schools in the future. High school juniors participate in the program during their junior and senior year. Students come to EC3 Erie West in the afternoon and follow the College's academic calendar. The students qualify for the program by meeting the same assessment that the College applicants are required to meet. If the applicants don't receive a qualifying score on their entrance assessment, they can follow a study plan to improve. When the students graduate from the program, they will have met their requirements for high school graduation and graduate with an Associate of Arts degree. A study time prior to class has been added to the program to allow the students additional time to study and complete assignments. The instructor is present during the hands on and planned study time. The first cohort is tuition free for students since the College currently has free tuition to Erie County residents. The Erie School District pays for fees, books, and transportation. The cohorts will continue to evolve in efficiency, cost, and enrollment now that EC3 Erie West is secured.

### **Presentation- Information Literacy**

Librarian and Learning Support Specialist Mari Howell presented. Ms. Howell explained how the library's function has evolved from a traditional library with hard copy books to an information literacy center where students find information on the internet and evaluate it for authenticity in an ethical manner. This knowledge can be used in problem solving at work, life, in addition to education and helps students meet general goals in evaluating solutions. Association of College Research Libraries (ACRL) took MSCHE standards and created a framework for colleges. Ms. Howells explained that her role has evolved as time has gone on, with students initially asking questions concerning technology issues to now asking reference questions. Ms. Howells collaborates with faculty to meet the needs of students and creates an

open, welcoming atmosphere for students. The EC3 library, while nontraditional, is used by students in a very traditional manner, serving as an area to study and a place to write and research papers. It is the academic hub of EC3. Students can have information overload when using the internet and are not familiar with the tools available to them. Ms. Howells demonstrates website evaluation, strategic researching with Google, scholarly vs. popular, article database (Academic Search Elite) and e-book database, plagiarism, and citations for the students. She provides a structure for students to research in the correct way. Through this one-on-one help students become comfortable and build trust within the library environment. Ms. Howells shared that the library can be accessed off campus and that her contact information is provided at the bottom of all syllabi. Ms. Howells also informed the Trustees that most of the classes use Open Educational Resources (OER) and that she provides these resources to faculty. This saves the EC3 students a significant amount of money while meeting their educational goals. The Trustees asked for a future presentation on OERs.

Resolution to Amend Board Policy V.A.2: Academic Standing

Information

The College is committed to the academic success of its students. College Policy V.A.2 Academic Standing is designed to ensure that students make adequate progress toward a degree. Students are expected to be in good academic standing to continue at the College. The grading system at the College is a letter system with associated quality points, which are used to compute cumulative grade point averages as follows: A=4, B=3, C=2, D=1, F=0. Developmental, transfer credit and non-credit courses will not be calculated in the student's cumulative grade point average (GPA). To remain in Good Academic Standing, a cumulative GPA of 2.0 or better must be maintained.

A red-lined version of this policy is attached herewith reflecting all the changes mentioned above for review.

Recommendation

It is recommended that the Board of Trustees approves the changes as presented to Policy V.A.2: Academic Standing.

**Policy: V.A.2: Academic Standing**

The College is committed to the academic success of its students. This Academic Standing Policy is designed to ensure that students make adequate progress toward a degree. Students are expected to be in good academic standing to continue at the College. The grading system at the College is a letter system with associated quality points, which are used to compute cumulative grade point averages as follows. A=4, B=3, C=2, D=1, F=0. Developmental and non-credit courses will not be calculated in the student’s cumulative grade point average (GPA). ~~A student’s academic standing is determined by the GPA required to meet academic standards based on credits successfully completed at the College. Students with a cumulative GPA of 2.0 or above are considered in Good Academic Standing.~~ To remain in Good Academic Standing, a cumulative GPA of 2.0 or better must be maintained.

Credits Hours Toward GPA*	Academic Warning Cumulative GPA	Academic Probation Cumulative GPA
Fewer than 17 credits	Below 2.0	N/A

**NOTE:**

~~Students whose cumulative GPA falls below a 2.0, but above the probationary level, are considered to be on Warning Status, as shown in the table above. Students on Warning Status are encouraged to take advantage of College support services.~~

~~A student is placed on Academic Probation if his/her cumulative GPA falls below the designated Probation threshold as listed in the table above. Students have two consecutively enrolled semesters including semesters of attendance, not to include summer sessions, to raise their GPA to a level above Probation. Students are encouraged to take advantage of the College’s support services for assistance. A student who does not raise his/her GPA above Probation after two consecutively enrolled semesters of attendance will have to stop out for one semester during which time the student is encouraged to use the College’s support services for assistance.~~

~~The College shall establish an Appeals process to enable students to request reconsideration of the requirement to stop out for a semester.~~

**Academic Caution:**

If, before a total of nine (9) attempted hours, a student’s term GPA is below 2.0, the student will be placed on Academic Caution status. This status serves as an alert, or caution, to ensure that the student is aware that their GPA does not meet EC3’s minimum requirements. Students on Academic Caution status *are strongly encouraged* to meet with academic advising staff to discuss strategies for improving their GPA.

**Academic Warning:**

If a student has attended more than one semester and their cumulative GPA is below a 2.0, they will be placed on Academic Warning Status. Students on Academic Warning Status *are strongly encouraged* to meet with an academic advisor to devise a plan to improve their GPA. To be removed from Academic Warning status, the student

must earn a term GPA of 2.0 or higher and a cumulative GPA of 2.0 or higher. If the student earns a term GPA of 2.0 or higher but still has a cumulative GPA of less than 2.0, they will remain on Academic Warning status.

**Academic Probation:**

If a student has been on Academic Warning status for at least one semester (cumulative GPA is less than 2.0) and earns a term GPA of 2.0 or less, they will be placed on Academic Probation status. A student on Academic Probation status has two (2) consecutive semesters, not to include summer sessions, to raise their GPA to a level above a 2.0. Students on Probation *are required* to meet with an academic advisor before they can register for the next semester.

**Academic Suspension:**

A student that fails to meet the cumulative 2.0 GPA minimum after two (2) consecutive semesters will be placed on Academic Suspension from the College for one (1) semester. A student on Academic Suspension may re-enter after one (1) semester but *is required* to meet with an academic advisor prior to registration. A student on Academic Suspension who has been re-admitted to the College must maintain a term GPA at or above 2.0 to be allowed to enroll in each subsequent semester until such time that their cumulative GPA reaches 2.0 or higher.

Students will have the opportunity to appeal for reconsideration of the Academic Suspension requirement to stop out for a semester.

EC3 will enter into a lease agreement with The Benedictine Sisters of Erie, Inc. effective January 1, 2023-December 31, 2023 for the property at 330 E. 10<sup>th</sup> Street, EC3 Erie East. The lease will include space on the third floor including 301, 303, 305, 306A, 306B, 307, 308, and utility expenses associated with those areas; restrooms of the three-story educational and community resource building; and four off-street parking spaces. The Lessee may offer to renew the Lease for two (2) additional one-year terms.

Lessee agrees to pay to Lessor as rent for the Leased Premises the base sum of Seventy-Seven Thousand Four Hundred and 00/100 Dollars (\$77,400.00) per year, payable in equal monthly installments of Six Thousand Four Hundred Fifty and 00/100 Dollars (\$6,450.00) in advance on or before the 1st day of each and every calendar month during the Initial Term of this Lease.

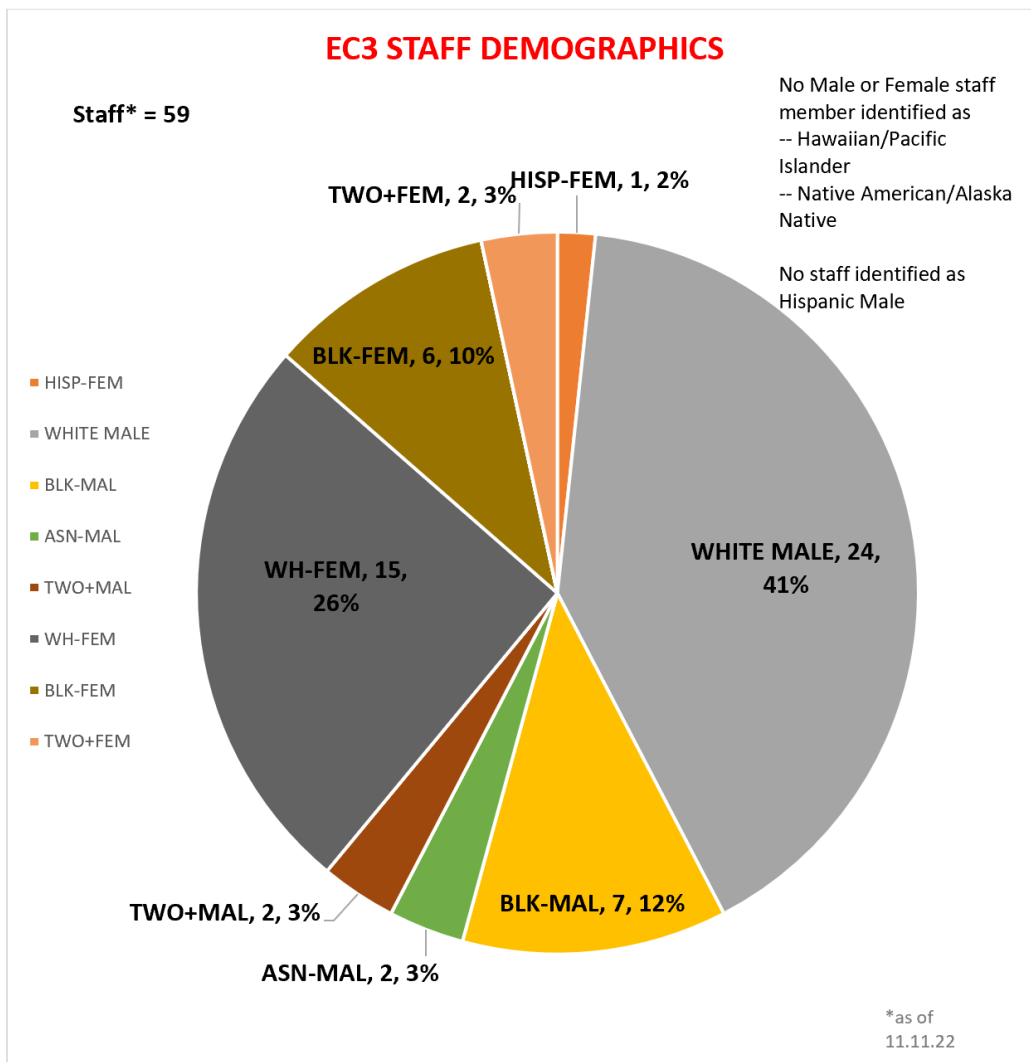
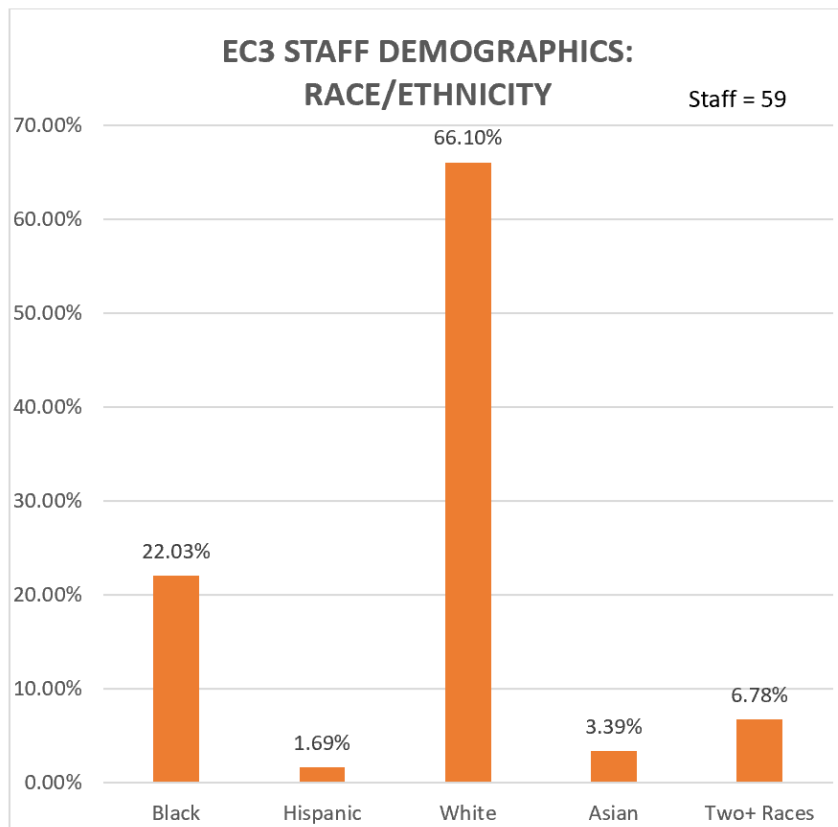

## **Presentation EC3 Key Performance Indicators**

Vice President Guy Goodman identified and presented five Key Performance Indicators (KPI) to the trustees including enrollment, success rates, retention rates, graduation rates, job placement, and transfer rates.

EC3's unduplicated headcount is up 74.8% and the Full Time Equivalent (FTE) is up 103.8% from Fall 2021 to Fall 2022. All KPIs are in expected ranges for the College and Mr. Goodman expressed his enthusiasm for the outcomes in Erie County but knows that there is still work to be done.

Trustees inquired how goals were going to be established moving forward now that there was a semester and annual baseline of data. Vice President Goodman responded that the next baseline would be the first graduating class and once accredited IPEDs (Integrated Post-Secondary Education System) will assign a comparison cohort. Vice President Goodman also noted that he has been comparing EC3 to Pennsylvania Highlands Community College the newest community college in Pennsylvania prior to EC3 and to Guttman Community College which is America's newest community college.

Vice President Goodman also answered questions concerning learning support for EC3 students which include tutoring outside of class, Success Coaches within the class that take the initiative to approach a student who needs additional support, and executive coaching and study skills that are all free to the students at EC3.

## **Presentation Preparing Students and Staff with Emergency Updates Using Regroup Emergency Notification Software**

Dr. Gray presented in Vice President William Jeffress' absence. Everyone with a College email is automatically signed up for the Regroup Emergency Notification Software. This is used to communicate important weather and emergency information updates. Messages are limited in the number of characters so it will refer students to messages in Blackboard and employees to emails or to contact their direct supervisor.
